Potential Regulatory Financing Adjustment

Introduction

We presented logging assessments in June 2011 and 2012, in which we outlined the potential for minor regulatory financing adjustments, to take account of circumstances that differ from those set out in the Final Determination. We have updated our submission to take account of changes in the first 3 years of the current regulatory period. Many of these circumstances are still subject to further change and we currently envisage that any required adjustment will be undertaken as part of the 2015-2020 strategic review of charges.

At 31 March 2013 the principal items that may need to be considered are:

Freezing of household charges in 2012/13

As a result of this decision by the Scottish Government, we expect to deliver out-performance back to customers early by not using our full entitlement to increase household prices by the household K factor of -5% across 2010-15.

Movements in Indexation

There continues to be movements and future uncertainty in indexation.

Non-Domestic Rates Revaluation

The impact of the 2010 rates revaluation which increases operating costs by £132m for the 2010-15 period. An increased Opex charge of £129m and increased PFI costs of £3m has been included in the Delivery Plan March 2013 Refresh.

Carbon Reduction Commitment Charges

Carbon Reduction Commitment Costs have been introduced for 2011/12 and may impact by around £3m per year out to 2014/15. An additional charge of £15m was included in the Delivery Plan March 2013 Refresh to reflect this item.

Taxation Changes

Changes in Corporation Tax rates and capital allowances were introduced in the June 2010 budget and adjustments were made in the Financial Statements in the Delivery Plan Update. As disclosed in the 2013 Delivery Plan Refresh, the estimated reduction of the taxation charge will be £52m in the regulatory period.

Changes in the OMGWG Register

Changes to the investment programme as set out in the OMGWG change register. The attached Appendix 1 shows the position of the changes to the Technical Expression for Q&S3b as at the 31st March 2013.

Capital Investment

Last year, we forecast that part of the regulatory investment programme will be delivered after March 2015. In discussion with the quality regulators, a list of priority projects, which could be delivered in the current regulatory period, were identified, and progressed with the agreement of the Outputs Monitoring Group.
